PUBLIC NOTICE OF A PUBLIC HEARING ON AN EPA OBJECTION TO THE VERMONT POLLUTANT DISCHARGE ELIMINATION SYSTEM (VTPDES) PERMIT MODIFICATION FOR THE WHITE RIVER JUNCTION WASTEWATER TREATMENT FACILITY, LOCATED IN HARTFORD, VERMONT TO DISCHARGE INTO THE WATERS OF THE UNITED STATES UNDER SECTION 301 AND 402 OF THE CLEAN WATER ACT, AS AMENDED.

**PUBLIC HEARING:**

The Vermont Department of Environmental Conservation (VTDEC), the Town of Hartford, U.S. Senator Leahy, U.S. Senator Sanders, and U.S. Representative Welch have requested that EPA convene a public hearing, pursuant to 40 C.F.R. §123.44(e), on the matter of EPA's objection to VTDEC's modification of the VTPDES permit for the White River Junction Wastewater Treatment Facility. On October 6, 2009, VTDEC public noticed a draft VTPDES permit modification for the White River Junction Wastewater Treatment Facility and on November 6, 2009, VTDEC issued the final permit modification. In a February 12, 2010 letter to VTDEC, EPA objected to the modified permit pursuant to 40 C.F.R. §123.44(c) due to procedural and substantive flaws, including failure to include provisions, in accordance with 40 C.F.R. §122.4(d) and §122.44(d), to ensure that the White River Junction Wastewater Treatment Facility does not discharge levels of nitrogen that will contribute to the water quality impairments in Long Island Sound.

Accordingly, a public hearing will be held on the following date and time:

**FINAL DECISIONS:**

Pursuant to 40 C.F.R. §123.44 (g), following the public hearing, EPA will either reaffirm the original objection, modify the terms of the objection, or withdraw the objection, and will notify the State of this decision. If EPA does not withdraw the objection and the State does not resubmit a permit revised to meet EPA's objection or modified objection within 30 days of the date of EPA's notification of decision, EPA may issue the permit in accordance with 40 C.F.R. Part 121, 122, and 124.
